PREFACE

The Transnational Intergovernmental Organization -"International Human Rights Commission" - IHRC, has its world headquarters in Zurich Switzerland, under the absolute leadership of the Secretary-General, Prof h.c. Rafał Marcin Wasik. IHRC is headed in Nigeria by the Ambassador-at-Large and Head of Diplomatic Mission, H.E. Ambassador Dr. Duru Hezekiah, who was appointed on the 16th of September 2022 after a comprehensive and legitimate background check on him came out justifiable. Before his official appointment as the Ambassador-at-Large and Head of the Diplomatic Mission in the Federal Republic of Nigeria, Dr. Duru Hezekiah was a Secretary to the IHRC Advisory Board and Acting Head of Mission in Nigeria.

IHRC is an influential private neutral organization recognized for its significant role in global security, peacebuilding, human rights, economic development, and diplomatic and humanitarian activities. IHRC pioneered the creation of the world's first private diplomatic intergovernmental and transnational organization, known as Transnational Intergovernmental Organization (TIO).

The organization operates on the basis of international conventions, including the Vienna Conventions of 1961, 1975 and 1986, and has obtained the status of a transnational intergovernmental organization through diplomatic agreements signed with governments represented by their Ministries of Foreign Affairs. These agreements are further complemented by cooperation with government agencies, the authorities of the autonomous republics, as well as regional and local authorities.

IHRC has operated mainly in the international arena in zones of war and military operations, territorial and national conflicts, and humanitarian disasters. On 3 continents, we closely cooperate with state authorities, creating conditions and securing platforms for official work and arrangements aimed at resolving conflicts and restoring the application of Human Rights. CHAPTER ONE

IHRC EUROPE-AFRICA COOPERATION: IHRC WILL PARTNER WITH THE NIGERIA GOVERNMENT, AFRICAN LEADERS TOWARD PEACE, SECURITY AND DEMOCRACY

The Secretary-General of the Transnational Intergovernmental Organization - International Human Rights Commission IHRC, Prof. h.c. Rafał Marcin Wasik, reaffirmed the Organization's dedication to fostering initiatives that promote peace and security, democracy, human rights, development, and sustainable economic growth in Nigeria through the IHRC Europe-Africa Cooperation.

The Secretary-General gave these assurances to government stakeholders during his maiden Delegation Visit to the Federal Republic of Nigeria in September 2023, on the occasion of the Organization's Symposium on International Humanitarian Law and Armed Conflicts: An African Perspective.

Part of the Delegation Visit was to the Institute for Peace and Conflict Resolution (IPCR), in Abuja on Thursday 7th September, 2023, led by Secretary-General Prof Rafal Marcin Wasik, accompanied by the IHRC Managing Director of Control Department H.E. Ambassador at Large J. Tatarowski and other officials of the Commission in Nigeria. The Delegation was received by the Director-General of the Institute Dr. Joseph Ochogwu, where issues on conflict resolutions, mediation, policy advisory, information sharing, peacebuilding, capacity building, humanitarian interventions, partnership, research, and training were deliberated. The Secretary-General expressed the readiness of the organization to offer intergovernmental platforms for communications, observation missions, and participation towards promoting the

culture of peace in Nigeria through the IHRC Europe-Africa Cooperation.

While responding, the DG IPCR Dr. Joseph Ochogwu, commended IHRC's global focus on human rights and peace building, emphasizes the core mandate of the Institute which is primarily inclusive in peace building. He further appreciated the Secretary-General and his team, adding that the Institute is ready to collaborate with the Commission to advance its efforts on peace building and conflict resolutions. In a bid to fortify transnational relationships between States and foster partnerships in combating human trafficking worldwide, the IHRC Delegates also paid a high-level delegation visit to the Director-General National Agency for the Prohibition of Trafficking in Persons (NAPTIP), Prof. Fatima Waziri-Azi on Thursday in Abuja.

The Delegation Visit to NAPTIP was an integral part of the events marking the Secretary-General's visit to Nigeria, aligning with the Organization's mission to safeguard human rights globally. Highlighting the IHRC Europe-Africa Cooperation's commitment to advancing information sharing and data policy in combating human trafficking. The NAPTIP DG Prof. Fatima Waziri-Azi, acknowledged the visit and assured the Commission of their readiness to harmonize the corporate partnership between the Agency and the International Human Rights Commission in Nigeria.

The IHRC Delegation on Saturday 9th September 2023, also visited the Executive Secretary of the Nigeria Christian Pilgrim Commission (NCPC), Rev. Dr. Yakubu Pam at Abuja, emphasizing the relations between the International Human Rights Commission in Zurich Switzerland, and African countries in peace and security, democracy, human rights, development, and sustainable economic growth. Furthermore, a meeting with Benue State Governor, H.E. Rev Fr. Hyacinth Alia, on Saturday, 9th September 2023, highlighted the urgent need for international humanitarian aid to support the people of Benue State.

The governor, in his remarks, lauded the International Human Rights Commission and urged them to consider Benue State as part of their Europe-Africa revitalization agenda for Nigeria.

In addition to high-level meetings that shape the relations, the Secretary-General reiterated that IHRC engages in dialogue with diverse partners to advance mutually agreed priorities intended to maintain constructive relations between states.

"With this aim in mind, IHRC will join forces with the Nigerian Government and other African Leaders to create a Pan-African strategy for fostering peace and security, democracy, human rights, development, and sustainable economic growth in Africa, guaranteeing the full protection of human rights for all people".

In conclusion, he said IHRC Head of Diplomatic Mission in Nigeria, H.E. Ambassador Dr. Duru Hezekiah will however, maintain the established communications with the Government ties in achieving the expected outcome between the International Human Rights Commission IHRC and the Federal Republic of Nigeria.

CHAPTER TWO

IHRC NIGERIA ADVOCATES FOR INTEGRATION OF HUMAN RIGHTS EDUCATION IN SCHOOL SYSTEM

During the celebration of the December 10th International Human Rights Day at the Federal Capital Territory, Abuja.

The Head of Diplomatic Mission for IHRC in Nigeria, H.E. Ambassador Dr. Duru Hezekiah, has urged national authorities to incorporate Human Rights Education (HRE) into the country's school system.

He made this call on Friday in Abuja during the commemoration of the 2023 International Human Rights Day, themed "Consolidating and Sustaining Human Rights Culture into the Future."

Ambassador Duru emphasized the pivotal role of HRE in shaping future generations and fostering a culture of human rights.

He stated, "I implore the national authorities responsible for Nigeria's school system to integrate HRE, contributing to the overall effectiveness of the education system. This, in turn, enhances the country's economic, social, and political development, providing:

- Improved quality of learning achievements by promoting child-centered and participatory teaching and learning practices, along with a redefined role for the teaching profession.
- Increased access to and participation in schooling by creating a human rights-based learning environment that is inclusive, welcoming, and promotes universal values, equal opportunities, respect for diversity, and non-discrimination.
- A contribution to social cohesion and conflict prevention by supporting the social and emotional development of the child and introducing democratic citizenship and values.

This call aligns with the 75th anniversary of the Universal Declaration of Human Rights, aiming to promote social cohesion, prevent conflicts, and contribute to economic, social, and political development. Stay tuned for further updates on this significant development."

CHAPTER FIVE

WE'RE COMMITTED TO PROMOTING ACTIONS AGAINST RACIAL DISCRIMINATION – IHRC

IHRC says racial discrimination undermines the fundamental principles of equality and human rights.

The International Human Rights Commission (IHRC) says it is committed to promoting equality, justice, and dignity in Nigeria.

Ambassador-at-Large and Head of the Diplomatic Mission of IHRC, H.E. Ambassador Dr. Duru Hezekiah, stated this in Abuja on Wednesday to mark the International Day for the Elimination of Racial Discrimination held on 21 March every year.

He said racial discrimination undermines the fundamental principles of equality and human rights.

He stressed that it also perpetuates systemic injustices that hinder the progress and well-being of individuals and communities. "It is imperative to recognise the inherent worth and rights of every human being and stand united against the scourge of racial discrimination that continues to plague the society".

"It is a barrier to social cohesion, economic development, and peace, and it is our collective responsibility to dismantle these barriers and build a more inclusive and equitable world for all," he noted.

Committed to the oppressed

Dr. Duru Hezekiah stated that IHRC is committed to advocating the rights of marginalized and oppressed communities and challenging discriminatory practices and policies that perpetuate inequality and injustice.

He called on various government institutions, organisations, groups, and individuals to intensify efforts to uphold the principles of equality, diversity, and respect for human dignity.

"Together, we can make a difference. Together, we can eliminate racial discrimination and build a more just and inclusive society for generations to come," he stated.

Background

On 21 March every year, communities worldwide commemorate the International Day for the Elimination of Racial Discrimination. The day is dedicated to honouring the **victims** of the 1960 Sharpeville massacre and rallying to combat racial discrimination.

In Sharpeville, South Africa, on 21 March 1960, peaceful demonstrators rallied against apartheid laws that enforced racial segregation.

Sadly, police gunfire claimed the lives of 69 people and injured many others. This event has become a symbol of the struggle against racial discrimination.

In 1966, the United Nations General Assembly designated every 21 March as the International Day for the Elimination of Racial Discrimination.

The day serves as a reminder to promote tolerance, understanding, and respect for diversity globally. People around the world participate in various events and activities, including educational workshops and cultural performances, to raise awareness about the harmful impacts of racial discrimination and advocate equality.

This year's observance of the International Day for the Elimination of Racial Discrimination is of significant importance given recent global events spotlighting ongoing racial injustices.

According to the Vienna Convention, the functions of a diplomatic mission include but are not limited to the promotion of friendly relations between two states and the furthering of their economic, commercial, cultural, and scientific relations.

It was in this regard that the Transnational Intergovernmental Organization – International Human Rights Commission (IHRC), and the International Society of Diplomats (ISD) – both Diplomatic Organizations in Nigeria, have reiterated a course of action towards promoting friendly relations between the Nigeria states and the furthering of their economic, commercial, cultural, and scientific relations against the background of Nigeria's nightmare on insecurity and terrorism.

The affirmation was reached during a familiarization visit by the International Human Rights Commission-IHRC led by its Ambassador-at-Large/Head of Diplomatic Mission in Nigeria, H.E. Ambassador Dr. Duru Hezekiah, to the Country Director of International Society of Diplomats, H.E. Prof. Edet Bassey Ekpenyong on the 30th day of May 2024 in Abuja.

Emphasis on heightened insecurities and its alarming dilemma on economic development, harmony, peace, stability, and security of the society, alongside its serious impediment on women and children which is becoming a disturbing concern for human society were discussed.

In his remark, the IHRC's Ambassador-at-Large/Head of Diplomatic Mission in Nigeria, H.E. Ambassador Dr. Duru Hezekiah noted that the concern, attention, and interest elicited among scholars, policymakers, or the larger society on negotiating, have never at any time in history measured anywhere as a failed strategy. "Because through negotiations parties reach a compromise of common interest", he added.

He maintained that as Diplomatic Organizations enshrined with the responsibility to build and foster cordial ties between states, IHRC envisaged a partnership with ISD where both organizations can play advisory roles and steer a motivating force on issues that have an impact on the welfare and human rights protection of Nigerians.

In response, the ISD's Country Director, H.E. Prof. Edet Bassey Ekpenyong expressed his delight and willingness to partner with IHRC, citing areas where both Missions can jointly seek dialogue and peaceful negotiation amidst the insecurity facing the nation, particularly in the South Eastern part of the country.

The duo organizations considered it imperatively benefitting to intimate the Federal Government and other related Stakeholders in driving this motion of decisive action that will be free from political propaganda and rather, foster commitments hinged on achieving peaceful coexistence in Nigeria.

Prof. Edet further promised to expedite the process for the partnership, while thanking the IHRC's Head of Diplomatic Mission for his keen interest.

CHAPTER NINE

6TH LEGISLATIVE: 2024 FIRST ORDINARY SESSION OF THE ECOWAS PARLIAMENT

(Being a Presentation of H.E. Ambassador Dr. Duru Hezekiah at ECOWAS Female Parliamentarians Association, Abuja)

H.E. Ambassador Dr. Duru Hezekiah IHRC Ambassador-at-Large/Head of Diplomatic Mission in Nigeria, was a Guest/Presenter at the 6th Legislative: 2024 First Ordinary Session of the ECOWAS Parliament Plenary of Thursday, 18th July 2024. It was an Interactive Session Organised by the ECOWAS Parliament in Partnership with the International Human Rights Commission (IHRC) in Nigeria.

In his presentation tagged, "Human Rights Situation in the West African Region", he emphasized the human rights violations in Africa such as human trafficking, child labor, gender-based violence (GBV), and discrimination at all levels, including the lack of quality education and access to justice, etc. He noted that international standards recognize access to justice as both a basic human right and a means to protect other universally recognized human rights.

"He said over the years, the International Human Rights Commission has received commendation from state and local authorities, as well as supranational and local organizations for its efforts in combating human trafficking". Adding that the primary goal of the IHRC Group is to promote and implement the legislation, customs, and standards applicable to the full extent of HUMAN RIGHTS and all the resulting principles of local and international coexistence.

Going further, he recommended:

- That building institution-centered justice systems, combating crime and corruption, and defending human rights are crucial to nation-building.
- And promoting the Rule of Law: engaging a highly consultative approach to the delivery of accountable framework, and policy, working with the justice sector and local stakeholders to develop programs that are responsive to African needs and interests should be prioritized by our African leaders.

CHAPTER TEN

PROTEST: IHRC CALLS FOR CAUTION, TASK TINUBU ON FEDERAL DIALOGUE COMMITTEE

A Switzerland-based intergovernmental Organization, the International Human Rights Commission (IHRC) in Nigeria, has commended the solidarity of Nigerians seeking good governance, however, urging them to embrace dialogue against protest as a means of restoring normalcy and reinstating inclusiveness in Nigerian society.

The Organization's Ambassador-at-Large/Head of Diplomatic Mission in Nigeria, H.E. Ambassador Dr. Duru Hezekiah asserted on Thursday in Abuja.

He recounted the hunger and economic hardship plaguing Nigerians particularly how it has advanced criminal activities by unscrupulous persons who are constituting mayhem, insecurity, and kidnapping in the broad daylight.

Regarding the agitated nationwide protest, Dr. Duru said let's give dialogue a chance. He acknowledged that although protest is a fundamental human right enshrined in Nigeria's

constitution, he noted that protesting as a medium of conveying agitations or demands has failed in recent times.

The fundamental rights of citizens are indeed the bedrock for managing and mitigating conflict, spurring economic growth, and protecting human dignity, while countries with democratic freedoms are more just, peaceful, and stable, and citizens can fulfill their potential.

He therefore called on President Bola Tinubu to constitute a Federal Dialogue Committee (FEDIC), an independent and politically active civil society network that will focus on strengthening and promoting accountable and transparent governance, dialogue, and negotiations as they span full respect for human rights, multi-actor partnership, equity, and responsiveness (to the needs of the people).

He said, our current efforts at nation-building and the modest achievements we have made as a nation over the years are the positive outcomes of the time and energy our forebears invested in national dialogues. We must, therefore, continue to embrace the culture of dialogue as a civilized way to settle our differences in Nigeria. According to him, Nigerians shouldn't embark on any protest, but rather give dialogue a chance, because dialogue is the most effective way to build consensus and resolve conflicts in any society; bringing people of different agitations to a round table where every concern can be fairly considered.

The Ambassador-at-Large decried the fears of hoodlums destabilizing the planned protest, which will leave many unanswered questions, irregularities, and uncomfortable government policies suffered by the masses still unaddressed but worsening the situation.

And the fact will remain that our people can no longer continue to live in penury, hence they'll always agitate, unfortunately, protesting about it will yield little or no results", he hinted.

"Mr. President, and as a father to the nation, this is the right time to demonstrate your administrative skills and fatherly knowledge; I implore you to establish the Federal Dialogue Committee, to address the real drivers with all key interest groups invited to participate, including civil society, women, youth, and other traditionally excluded groups, this could salvage the nation from anarchy". "I have the hope that Nigerians will embrace dialogue and desist from the planned protest, with the assurances that President Tinubu's Administration will as well engage effectively. Let's give them time to rebuild our nation".

CHAPTER THIRTEEN

IHRC DEMANDS IMMEDIATE GOVERNMENT INTERVENTION ON DETAINED MINORS

The International Human Rights Commission – IHRC in Nigeria has expressed concern over a circulating video showing 124 protesters, including minors with visible signs of malnutrition and exhaustion, arraigned in court on Friday, 1 November 2024, for allegedly protesting against bad governance that affects their livelihood, a fundamental right protected by Nigeria's democratic constitution

This was obtained in a press statement issued on Saturday, 2 November, in Abuja by the Commission's Ambassador-at-Large and Head of Diplomatic Mission in Nigeria, H.E. Ambassador Dr. Duru Hezekiah.

According to the Ambassador-at-Large, the disheartening incident serves as a powerful reminder of our collective responsibility to protect human rights, appealing to the Federal Government for a drastic intervention. He underscored the human rights concerns surrounding Nigerian minors in Kuje Prison and other correctional facilities, emphasizing that Nigerians must prioritize this issue, recognizing our shared obligation to protect human dignity within the global community.

Furthermore, Dr. Duru emphasized that the Organization strongly disapproves of juvenile delinquency in all its forms, including, vandalism, theft, violence, and gang involvement. Nevertheless, it recognizes that individuals in correctional facilities retain their inherent dignity as human beings.

While I commend the presiding judge's intervention in halting the trial, I urge the Minister of Justice and Attorney-General of the Federation, Law Enforcement Agencies, to thoroughly investigate and prevent such injustices, fostering a society where dignity and justice thrive.

In conclusion, I implore the Nigerian Government to reiterate its commitment to child rights, as outlined in the United Nations Convention on the Rights of the Child (CRC), African Charter on the Rights and Welfare of the Child (ACRWC), Nigerian Child Rights Act (2003), and the National Youth Policy (2019), through the Nigerian Child Rights Committee and Prisoners' Rehabilitation and Welfare Action (PRWA), to fulfill its responsibilities.

CHAPTER FOURTEEN

IHRC APPLAUDS NIGERIAN GOVERNORS ON MINIMUM WAGE IMPLEMENTATION, CALLS FOR EQUITABLE, SUSTAINABLE PRACTICES

Recent discussions have centered around the nexus between Nigeria's economic growth and the benefits of its minimum wage policy.

The Diplomatic Mission of the International Human Rights Commission-IHRC in Nigeria commends Nigerian Governors who have initiated the implementation of the new minimum wage, signed into law by President Bola Tinubu in July 2024 and encourages them to uphold equitable and sustainable practices.

H.E. Ambassador Dr. Duru Hezekiah, the Commission's Ambassador-at-Large and Head of Diplomatic Mission in Nigeria, issued this statement on Friday, November 8, 2024, in Abuja, through a correspondence released to the press, stressing that the minimum wage increase in Nigeria is a step towards improving employee living standards and reducing poverty.

He said, "The International Human Rights Commission-IHRC extends its heartfelt commendation to Nigerian Governors Francis Ogbonna Nwifuru of Ebonyi State, Seyi Makinde of Oyo State, Sheriff Oborevwori of Delta State, Muhammad Yahaya of Gombe State, and others, for their exemplary commitment to implementing minimum wage in their respective States, showcasing their unwavering commitment to serving the public interest".

Given the prevailing economic hardship in Nigeria, Dr. Duru pointed out that the wage increase is expected to provide affected employees with enhanced disposable income to satisfy basic requirements and augment their overall wellbeing, encouraging other state governors to emulate it.

"Similarly, businesses that offer higher wages create a more attractive work environment, encouraging employees to stay longer and reducing turnover rates", he maintained.

He underscored the vital need for equitable and sustainable practices in implementing the minimum wage, emphasizing how this benefits workers, businesses, and the economy, and urged Governors to embrace it. Recall that the country recently increased its minimum wage from \aleph 30,000 to \aleph 70,000, marking a 133% increase. This change aims to enhance the income of low-income households, ultimately improving their living standards and enabling them to meet essential needs.

IHRC SEEKS ACTIONABLE PRACTICES TO END VIOLENCE AGAINST WOMEN AND GIRLS.

Marking International Day for the Elimination of Genderbased Violence, the International Human Rights Commission (IHRC) in Nigeria underscores the disturbing increase in violence against women and girls across the globe.

The Commission in a statement by the Ambassador-at-Large and Head of Diplomatic Mission in Nigeria, H.E. Ambassador Dr. Duru Hezekiah, stands in unison with the global community, comprising civil society organizations, Gender Justice movements, and international development partners, to undertake collective action aimed at revitalizing commitments and calling for accountability and action from stakeholders at various levels, from local to international.

Dr. Duru lamented that despite global and local efforts, approximately one in three women in Nigeria have been victims of violence, emphasizing that the statistics are alarming and unacceptable. He said we must also fight rigid gender norms and stereotypes that perpetuate unhealthy masculinity and violence based on gender.

He urged Special Monitoring Mission Officials in Nigeria to coordinate activities and participate in high-level advocacy meetings marking the 16 Days of Activism Against Gender-Based Violence (GBV), an annual international campaign that commences on 25th November, the International Day for the Elimination of Violence Against Women and Girls and concludes on 10th December, Human Rights Day.

HUMAN RIGHTS INTERVENTIONS AND SPECIAL MONITORING MISSION

INTERVENTION ONE

HUMAN RIGHTS STAKEHOLDERS STRESS NEED FOR COLLECTIVE ACTION IN ACTIVISM - IHRC

Stakeholders have expressed concern about consolidating and sustaining human rights into the future, highlighted crucial challenges faced by law enforcement agencies in discharging their duties, and called for synergy between actors to ensure fundamental human rights of citizens are not compromised.

The Special Monitoring Mission of the International Human Rights Commission-IHRC South/South Region reports that the various stakeholders comprising the Police, National Drug Law Enforcement Agency (NDLEA), the Nigeria Army, including the Delta State University Abraka, and other Civil Rights Groups spoke at her 2023 end of year Human Rights Stakeholders Summit on Saturday in Abraka Delta State.

The various stakeholders expressed concern over the development, with an emphasis that the summit will help to develop a comprehensive experience of human rights advocacy hinged to provide creative, concrete knowledge of how to use international and regional human rights treaties and enforcement mechanisms in their work for the protection and promotion of human rights.

They bemoaned the non-compliance to human rights laws, particularly from those who are entrusted to protect and uphold them, ranging from the home, community leaders, political actors, and law enforcement agencies while anticipating the integration of knowledge in the fields of politics, economics, cultural diversity, gender issues, security, and socio-psychology in the context of human rights.

Fidelis Onakpoma, the Regional Coordinator for IHRC Special Monitoring Mission South-South Region, in his opening remark conveyed the commendation of the IHRC Ambassador-at-Large and Head of Diplomatic Mission in Nigeria H.E. Ambassador Dr. Duru Hezekiah to various stakeholders for participating in the one-day human rights summit, imploring them on the need for effective collaboration towards consolidating and sustaining human rights into the future.

He said IHRC was deeply concerned about synergy's approach and the application of a comprehensive experience

of human rights advocacy on how to use international and regional human rights treaties and enforcement mechanisms in their work for the protection and promotion of human rights.

He explained that tertiary institutions, human rights educators, activists, law enforcement officers, lawyers, women activists, research officers, leaders, members of coalitions and networks, staff of NGOs and CBOs, volunteers, development actors, trainers, and students, participated in the summit.

"As stakeholders, we will leverage our partnerships by creating awareness, and implementing enforceable regulations that can help in reducing human rights violations in our communities".

CP Wale Abass, the Delta State Commissioner of Police, commended IHRC's idea on the one-day stakeholders engagement, assuring the stakeholders of the Police's commitment to the quest for any cause that would consolidate human rights into the future.

The CP who was ably represented by the DPO of Abraka Police Station SP Fabian Efehi Ayameh, stressed that the alarming consequences that have emerged due to noncompliance to human rights cannot be ignored.

He noted that apart from human rights actors being worried about the situation, citizens are getting perturbed that their fundamental human rights are being compromised gradually while appropriate government agencies look the other way.

"But through this summit, information sharing and fruitful exchange of ideas on enforceable and emergency response, considered to bolster human rights compliance and effectively address any human rights related incidents that may occur, will be established, courtesy of the International Human Rights Commission-IHRC".

The Commissioner of Police further said that training programs, and capacity building for policemen and paramilitaries working with the Nigeria Police such as the Vigilante and Anti-cult, will be implemented to enhance their mode of operation in compliance with human rights laws. "The fundamental human rights of our citizens are nonnegotiable, and we will leave no stone unturned in protecting their lives," he said.

Similarly, the State Commander of NDLEA Delta State Command, Barr. Abubakar Wada, represented by ASN. Cletus Nduka Ndubuisi said there was a need for all stakeholders to double their efforts, not only in the area of collaboration but also in enlightenment.

Prof. Andy Ogochukwu Egwunyega, Vice-Chancellor of Delta State University Abraka (DELSU), represented by Prof. Ben Nwane also stressed the need for synergy and collaboration between all the stakeholders.

He noted that DELSU under the indefatigable leadership of Prof. Andy Egwunyega has attained milestone achievements with compliance to human rights laws such as gender equality, no sex for grade, sexual harassment policy, inclusion, and good governance, to mention but a few.

DELSU had a lot of implementable and enforceable policies safeguarding fundamental human rights, adding that their

efforts to consolidate and sustain human rights into the future of the institution remain unwavering.

Pastor (Comr.) Edewor Egedegbe, Chairman Human Rights Protection Congress, asserted that as much as we ensure that more people comply with human rights laws, as we hold our abusers accountable, the issue of education and enlightenment of the public cannot be overemphasized.

"By advocating for sustainable practices, formulating effective policies, and strengthening the capacities of the state, we strive to mitigate the human rights violations in our state", he hinted.

In his recommendations on what should be done to consolidate and sustain human rights into the future, he submitted that:

- Citizens should be responsible for supporting and providing reliable information to security agencies in a bid to ensure peaceful co-existence.
- 2. Community leaders should not aid and abate criminals in their community for selfish reasons because a

peaceful community is a potential community for development.

- 3. Security agencies should earn citizens' trust through their actions, and not make themselves enemies of the people they intend to protect through oppression, violation of constitutional rights, extortion, etc.
- 4. Security agents should not allow themselves to be used to undermine the laws of the land/court orders by political office holders and money bags, for their selfish interest thereby neglecting the rule of law in a democratic dispensation where the office of the citizen is the highest in the land.
- 5. Government should ensure and make adequate provision for the well-being of its citizens and security personnel, and should not use "the people's power" vested in them against the wishes and aspirations of the people.

6. Patriotism should take center stage for all citizens whether officers or citizens alike and not engage in parochialism and bigotry.

The epoch event with the sub-topic "Justice and Human Rights: A Panacea for Peace in Imo State took place at Rock-View Hotel Owerri and was well attended by various human rights stakeholders such as the State Attorney General and Commissioner for Justice, Imo State Commissioner of Police, Director of Department of State Security (DSS), Nigeria Correctional Service (NCS), Nigeria Security Civil Defense Corps (NSCDC). Others include the National Orientation Agency (NOA), National Human Rights Commission (NHR), National Agency for the Prohibition of Trafficking in Persons (NAPTIP), Student Union Government (SUG) Imo State University, Religious and Traditional Heads, Civil Society Organizations and the Nigeria Union of Journalist (NUJ).

Ambassador Dr Duru Hezekiah to the CP, commending him for his unrelenting efforts in combating crimes in Imo State, stressing that the Ambassador-at-Large Dr. Duru Hezekiah hails from Imo State and he's well pleased with his antecedents. Moreover, Chiemeziehe thanked the CP for adopting an opendoor policy that made the visit possible despite various attempts in the past and also appreciated the CP for honoring the Commission's invitation to attend her Human Rights and Peace Summit, represented by ASP Henry Okoye.

He stated that the aim and objectives of the organization were to ensure that the human rights and dignity of people are upheld without fear of brutality, harassment, and unlawful incarceration and detention.

Availing that the International Human Rights Commission in Imo State is willing to partner and collaborate with the Police in ensuring that the rights of residents of Imo State are protected.

He also praised the gallant efforts of the men of the Command, who have put their lives and families on line to ensure the safety of the people of Imo State.

Finally, he re-emphasized collaboration and partnership with the security agency in promoting human rights in the state, urging the CP to establish a liaison office within the State Police Command for a prompt and speedy response towards issues surrounding human rights violations in the State.

In response, CP Danjuma appreciated the Commission's visit and its call to collaborate in ensuring human rights are protected, noting that human rights form the bedrock of sustainable peace.

According to Danjuma, he always advocated for the rights of a suspect to contact his counsel and apply for bail where applicable, maintaining that their rights to medical care, and to be taken care of are ensured.

He further expressed displeasure at the report of human rights violations associated with some of his men, noting that various mechanisms such as the X-Squad, Public Complaint Unit, and the PPRO office have been put in place to curtail, cut down, and put to check the activities of the Police Force in the Imo State Police.

Finally, he thanked the team for coming and directed the Deputy PRO, Ms. Fyebe, to the office of the X-Squad.

Therewith, ACP Barr. Linus Nwigwe, the head of the X-Squad commended IHRC's work reaffirming the commitments of the Command in ensuring that no one in the State is intimidated, extorted, or unlawfully detained by men of the Police Force.

Other members of IHRC Special Monitoring Mission Officials present at the courtesy visit were Comrade Linda Dike and Comrade Immaculate Onwuachukwu.

Recall that the International Human Rights Commission-IHRC is a Transnational Intergovernmental Organization with World Headquarters in Zurich, Switzerland, headed by Secretary-General Prof Rafał Marcin Wasik IHRC World Chairman, and in Nigeria by H.E. IHRC TAKES 16-DAYS ACTIVISM TO IDP CAMP

NGA: As part of the global 16-Days Activism to End Genderbased Violence (GBV), the International Human Rights Commission Special Monitoring Mission (IHRC SMM) in Borno State, visited Bakassi IDP Camp in Maiduguri MMC Local Government Area.

Comrade Mohammed Adamu, Zonal Coordinator of IHRC SMM Borno State, explained that the advocacy visit was intended to raise awareness among residents of the camp about gender-based violence (GBV) and the support services available at the Women and Girls Safe Space (WGSS).

The session underscored the importance of prioritizing girls' education and the procedures for reporting GBV incidents to the relevant authorities, highlighting the critical role young people play in ending gender-based violence and cultivating a culture of equality and respect. He said the interactive discussions encouraged open dialogue and inspired IDPs to become advocates for a violence-free society.

He urged IHRC SMM Officials to persist in their efforts to create a future where every woman and child can live without fear, without harm, and with the dignity and safety they deserve.

The IHRC has been officially recognized as a diplomatic organization in several countries, enjoying the associated privileges and immunities under international law. Although the IHRC is not affiliated with the United Nations (UN) and does not operate as an agency of the UN, it cooperates with the UN on various initiatives.

IHRC in accordance with the provisions of its Statute, issues Diplomatic Laissez-Passer cards, Diplomatic Travel Order cards and CD vehicle marking 95 authorizations to its members participating in IHRC Diplomatic Missions.




