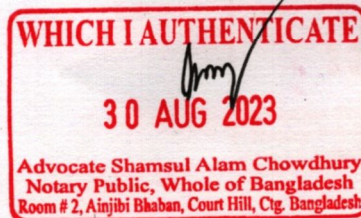

3. Preliminary Capital of the Organization: The preliminary capital of this organization will be TK. 10,000/-.
4. Operational Area: Whole of Bangladesh and independent and sovereign countries affiliated to United Nations.
5. Type & Nature of the Organization: Special Monitoring Mission International Human Rights Commission Bangladesh Trust is non-profitable, autonomous, voluntary, non-government & non-political human rights and charitable organization. The organization is strongly committed to implement fundamental rights by giving free legal aid to the persecuted community and to continue legal struggle on their behalf for the purpose of establishment of all democratic and fundamental rights guaranteed by the constitution of Bangladesh. Special Monitoring Mission International Human Rights Commission Bangladesh Trust is established for the purpose of implementation of humanitarian objects as to health, mental health and accommodation of the community whose human rights are persecuted, who are poor, helpless and financially insolvents and marginalized community mentioned in "30 sections of the charter of universal human rights" at Paris Declaration made by UN General Assembly on 10th December, 1948. - c) To establish and manage hospital, clinic and charitable hospital for the purpose of securing health service for the community deprived of health service and facility. Besides this to give financial assistance as per as possible to other establishments which are managed for the aforesaid purposes, to increase public awareness for preventing global epidemic like HIV, Aids, Dengue, Covid-19 etc. and take and implement programs against drugs.

- d) To uphold image of judiciary by taking necessary steps for the purpose securing availability of justice, to take steps against extra judicial detention, to secure rights of the prisoners through inspection of jail regularly and to act for the purpose of building up trust and confidence of the people toward judiciary.
- e) To give financial assistance through scholarship among insolvent, poor and talented students for the purpose of development of education and culture.
- f) To establish, manage and patronize signing center, library and multipurpose social training center for the purpose preventing moral turpitude. To encourage and give assistance for getting admission in government technical education institutes.
- g) To establish and manage general & special health and technical education school, college and other education institutes for the purpose spreading knowledge among small and indigenous community.
- h) To arrange national/international seminar, symposium and interreligious ceremony for the purpose of securing equality & social justice, waking up universal brotherhood and developing social awareness. To do honor the persons or institutes acquiring success in national and international field by giving honorarium/crest.
- i) To empower the low benefited community and to observe violation of human rights and to empower subordinate section of society by giving legal aid.
- j) To continue attempt to establish peace in Bangladesh and in the world for preventing militancy, terrorism, extremism, bomber communal harmony.
- k) To take and implement the program of pure water supply, mosquito killing, sanitation, sewerage and waste management for saving the environment and program of plantation of fruit, forest and medicinal trees for maintaining balance of environment. To encourage the people to keep drain, sewerage and canal beside the house clean. To aware the people as to bad effect of illegal occupation of canal and river.
- l) To take planned housing project in any area of the country for the purpose of removing housing problem and to establish and conduct elderly home for shelter less old persons are deprived of advantage.
- m) To publish higher research related journal, to establish satellite TV, IPTV and to arrange virtual dialogue for the purpose of building up an enriched nation.

- p) To make awareness against adulterant in food, cheat in weight and purchase of rotten and stale food by hotel & restaurant.
- q) To make awareness against mixing formalin with fruits, fishes, meats and vegetables.
- r) To stop ridding and getting down passengers of mass transports carrying passengers here and there and to encourage the owners to clean seat cover of the transport regularly. To take measure so as to any vehicle without driving license and fitness cannot drive in the road and to develop standard of the passengers' service.
- s) To provide the law enforcing agency with the assistance against the gang involving with militancy who are creating sabotage and unrest.
- t) To play role in creation of clean environment for development of life style of the slum community. To donate foods and medicines to innocent, insolvent, helpless and poor families. Under no circumstance money may be invested on interest.
- u) To make awareness among young people as to motor-bike accident and to discourage to go abroad through illegal channel on board.

7. Income:

The income source of the organization is admission fee and annual subscription of the members, lump grant, donation etc. Any income and asset of the organization will be used only for implementation of objects and purposes of the organization and no portion of it can be given or transferred to any member or to any person through the member directly or indirectly as dividend, bonus, salary or any remuneration in lieu of salary or hand cost etc.

7(1). Collection & Use of Fund:

- (a) The account will be opened in the name of the organization in one or more than one scheduled bank approved by Bangladesh Bank. The banking transaction will be completed through joint signature of any two amongst chairman, secretary general and finance secretary. Donation and cash money may be collected from any person, firm, body, organization, society or foundation or association and it will be used for implementation of objects and purposes of the organization and in case of receiving foreign donation, the provisions of the Foreign Donation Act 1978-XLVI will be followed and the specified formalities will be followed for the foreign donation and the organization will not receive any foreign donation without following the specified formalities for foreign donation.
- (b) All amounts of fund of the organization or any portion thereof will be disbursed for formation and management of the foundation or for implementation any particular project or for payment of salary of person(s) employing in the project and for

- General meeting and extra ordinary general meeting will mean a general meeting and an extra ordinary general meeting respectively.

11. Classification of Members: The members will be classified in 03 types.

(a) Founding Member, (b) Ordinary Member, (c) Life Donor Member

11. (a) Founding Member: The persons signing memorandum of association on the day of registration of this organization under the Societies Registration Act No. XXI of 1860 will be considered as the founding members of this organization. If there is any probability of causing any major harm to the organization due to inability of executive committee of the organization, the founding members can form the convener committing winding up the executive committee upon unanimous decision. The chairman of the executive committee can contest for any post including the post of convener at any time. Notwithstanding Lion Mohammed Elias Siraji holds any post of this organization as the entrepreneur and founder of SMMIHRC Bangladesh, he will get honor from the organization. If he retires from the activities of this organization, he will be directly nominated as the chief advisor of the advisory council of this organization and if other founding members retire from the organization, they will be gradually members of the advisory council.

11. (b) Ordinary Member: Any citizen of Bangladesh of sound mind and of 18 years of old, who is attempting to protect human rights and not punished the court, can apply for getting membership by fulfilling the specified membership form and they will be treated as the ordinary members. Each ordinary member has to pay an amount of TK. 1,000/- (one thousand) only as the membership fee to Special Monitoring Mission International Human Rights Commission Bangladesh Trust. Each ordinary member has to pay total an amount of TK. 1,200/- (one thousand two hundred) only as the annual fee at the rate of monthly TK. 100/- (one hundred) only. During the time of formation of convener committee/executive committee, the ordinary members can contest for all posts without convener/chairman/president and secretary general/member secretary.

11. (c) Life Donor Member: Any person who is interested to the activities of this organization and not bound by the constitution of this organization, he can get membership by paying a cash donation of at least TK. 20,000/- (twenty thousand) only. Membership form will be distributed and received at office hours on any working day in the office of the organization by member or officers of the organization and membership fee including other fee has to be deposited in bank account of the foundation. The life donor members can contest for all posts without convener/chairman/president during the time of formation of the committee.

- * Each member of the organization will be entitled to give one vote. If annual fee of any member is remained due, he will be deprived of right to vote. Any member defaulting to pay due or outstanding fee for two consecutive years will lose his/her membership.
- * If any member is punished or declared as insolvent by the court, the membership of such member will be cancelled without any notice.
- * If any member commits any act against interest of the organization or if it is proved that, he has misappropriated any fund of the organization; his membership will be cancelled as per decision of the executive committee.
- * If any member of the executive committee/convener committee fails to attend in three meetings consecutively, any other member will be nominated in his place unanimously in the 3rd meeting.
- * The credit of any particular fund will be used by the executive committee only for particular objects; not otherwise.

12. Organizational Structures:

The organizational structures for management of the organization are four:

- a) General Committee,
- b) Convener Committee/Executive Committee,
- c) Advisory Committee,
- d) Organizational Committee. However this organization will perform activities in Bangladesh as an associate organization of International Human Rights Commission, International ID No- 5967023. The founder and international secretary general of this organization Sir Rafel Marsin Wasik can give any decision for interest of the development of this organization as the international chairman and secretary of this organization and such decision shall be predominant over all decisions of all committees of this organization.

12. (a) General Committee:

The general committee will be formed by consisting of all members, but there shall be no maximum limit of members of the general committee. The chairman of the foundation will preside over all meetings of the general committee.

12. (b) Convener Committee/Executive Committee:

The executive committee will be formed unanimously by 2/3rd majority of the members in the general meeting. If it becomes impossible to form the executive committee, then convener committee will be formed.

A convener of the society will be formed by consisting of 07 (seven) members amongst whom 01 will be convener, 02 will be joint conveners, 01 will be secretary and remaining persons will be members. Such committee will form the executive committee through general meeting or election and deliver the power to the executive committee and after formation of fully body of the executive committee and up to delivery of the power to the elected committee, the convener committee will perform all functions of the organization.

12. (b2) Executive Committee:

The number of members of the executive committee will be at least 07 (seven). The functions of the organization will be operated by an executive committee who will entrusted with duty to determine the instructions and facilities of social activities and election of the executive committee will be determined by vote of the ordinary members or subject to discussion. The executive committee will control financial power of the organization. The duration of the executive committee will be at least for a period of 5 years. The scope of the activities may be extended by forming branch committee based on district, upazila, thana, pourashava, union and ward, but it must be unanimously approved by executive committee.

The formation of executive committee of the organization is as follows that will be consisting of 11 (eleven) members:

1. Chairman of the organization: 01 (one) person.
2. Vice-Chairman of the organization: 02 (two) persons.
3. Secretary General of the organization: 01 (one) person.
4. Joint Secretary General of the organization: 01 (one) person.
5. Finance Secretary of the organization: 01 (one) person.
6. Organizational, publication, education, health and relief secretary of the organization: 01 (one) person.
7. Law, information, woman, forest and environment affairs secretary of the organization: 01 (one) person.
8. Office and social welfare secretary of the organization: 01 (one) person.
9. Executive Member of the organization: 02 (two) persons.

Total: 11 (eleven) members.

12. (c) Advisory Committee:

The executive committee will unanimously form an advisory committee for a period not less than 02 years. The advisory committee will give advice to any issue arisen at any time. The members of the advisory committee must be elected amongst the founding members and the life donor members. The senior vice-chairman will perform the duty as

the chief advisor for a period of 02 (two) years subsequently since the receipt of the written letter of the chairman. There shall be an advisory committee consisting of 09 (nine) members. The chairman and the chief advisor will make nomination of the advisory members upon discussion.

12. (d): The organizational committee will perform the duties as to different matters conferred by the chairman.

13. Duties & Functions of the Executive Committee:

13.1. **Chairman (National Coordinator):** Chairman will be head and chief of all functions of the organization.

He will be elected by vote of ordinary members in general meeting of the organization and he will hold the office up to election of his successor in office. However he will be qualified for re-election. If the chairman resigns or dies or remains absent or cannot perform the duty of his office due to illness or for any other reasons, the vice-chairman the duty as the acting chairman so long as the chairman is elected in the annual general meeting. The chairman/president/convener must be elected or nominated amongst the founding members. The chairman can discharge or remove any member for his immoral activity or for his activities against the organization and the country.

13.2 Vice- Chairman:

In absence of the chairman, the vice-chairman will perform duties of the chairman and any other special duties conferred by the executive committee. If the post of vice-chairman is remained vacant for any reason, the executive committee will elect vice-chairman as soon as possible. The vice-chairmen will perform the duties as per roll.

13.3 Secretary General:

The secretary general will perform all functions of the organization. The secretary general will be the executive director of the organization. He will be elected for a period of 02 years. He will always try to implement all objects and purposes of the organization and perform all administrative functions of the organization. All attempts of the organization will be conducted by the secretary general and he will have power to make proposal for appointing advisors, consultants, officers-employees and for their removal. If it is required to raise any object any member or members of the executive committee, the secretary general will submit the same to the general meeting. The secretary general/member secretary must be elected from the founding/donor member.

The joint secretary general will perform the duties conferred by the chairman and the secretary general. If the post of the secretary general becomes vacant due to any reason, the chairman will confer the duties of the secretary general on anyone of the joint secretaries general as the acting secretary general. He will perform all functions in the meeting of the executive committee and in the meeting of society for the purpose of aiding the secretary general i.e. the executive director. He will prepare and submit all report of all activities including all meetings of general committee and executive committee. He will give safe custody of seal and other records, files and documents.

13.5 Finance Secretary:

He will maintain all accounts and cash books of the organization properly. The finance secretary will be chief finance officer of the organization. He will responsible to the executive committee directly or indirectly for receipt, maintenance and distribution fund and other assets of the organization. He will deposit the amount more than 5,000/- (five thousand) only without keeping the same at own hand.

13.6 Joint Finance Secretary:

He will perform the duties in absence of the finance secretary. He will deposit the amount collected from the members in the bank.

13.7 Organizational Secretary:

He will take all sorts of action and implement the same upon instruction of chairman/secretary for strengthening organization structure of this organization. He will always be active in the activities of the organization.

13.8 Joint Organization Secretary:

He will perform the duties in absence of the organizational secretary.

13.9 Publication Secretary:

He will continue publication functions for interest of the organization as per rule. He will deliver notice of all meetings of the organization along with the members as instructed by the organization. He will perform the duty for publication of journal. He will perform all sorts of publication related activities upon consultation with chairman/secretary.

13.10 Office secretary:

He will write minutes of meetings including performance of the duty as to maintenance of all official, organizational and important documents and incidental assets of the organization.

The executive members will try to make plans and programs for implementation objects and purposes of the organization as well as they will be entrusted with the duty to reserve fund of the organization subject to instruction and approval of the executive committee.

14. Meeting of the Executive Committee:

14.1. The quorum of the meeting of executive committee will be formed by 2/3rd members of the executive committee and each of the members will have right to one vote. The meeting of executive committee will not held for more than 06 (six) months in a year.

14.2. There shall be an office secretary in the office of the organization who will write down name and address of all members. He will submit name, address, mobile number, e-mail, profession and nationality of the members.

14.3. Any decision in the meeting of executive committee will be adopted or denied upon opinion of majority of members and in case of equal number of vote, the chairman of executive committee will give his casting or second vote.

14.4. The secretary general may call emergency meeting on the notice of 24 hours including the specific agenda at any emergency situation.

14.5. If any post is vacated due to death, resignation, removal or any other reason, it will be filled up by any member of general committee upon decision of the executive committee or the vacancy will be filled up in any alternative way.

14.6. The executive committee will not do any act by amending any particular part of constitution of the organization and if any defect is found in the constitution by the executive committee or any member, any law or proceeding will not be invalid.

14.7. Annual General Meeting:

The annual general meeting will be held at least once in a year. Notice of general meeting mentioning date, time and place of general will be given to each member before 7 (seven) days. However any meeting may also be held through short time notice.

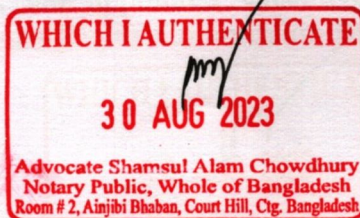
14.8. The quorum will be formed in each general or particular meeting by appearance of 2/3rd members. If the quorum is not formed, the meeting will be postponed. In absence of the chairman, the person amongst the present vice-chairmen nominated and supported by the members will preside over the relevant meeting.

15. Fund:

15.1. The fund of the organization will be formed from membership fee, annual fee, donation, greeting fee received from members of the organization, income from business and assets and donation of non-government national and international organization.

15.2. The members of the organization can engage in research programs or any other legal activities. However they can get remuneration for conducting such activities upon approval of the executive committee.

16. **Seal:** The executive committee will provide a seal for the organization. The seal will always be remained with the secretary general.

17. **Audit:** The income & expenditure account of the organization will be audited by any chartered accountant firm approved by the government or a social welfare officer and the audit report has to be approved by the annual general meeting.

Use of Flag of the Organization:

18. The leaders approved as young ambassador, peace ambassador, goodwill ambassador, ambassador, at large from international office and engaged by the international office can use international flag in the car.

19. Dissolution or Winding Up:

If the organization is dissolved or wound up or if any probability for its winding up is arisen at any time and if there remains any balance of money or asset after payment of all loans and liabilities of the organization, then all movable immovable assets and records of the organization will be transferred to any registered social welfare organization having same objects and purposes of this organization. But it will be adopted upon final decision of 2/3rd majority of members of the organization.

20. **Amendment:** If the executive committee of the organization deems necessary, the can propose/recommend to amend, modify, add, omit and limit any section, sub-section or word of the constitution. Such amendment or modification has to be approved by vote of 2/3rd majority of the members in the annual general meeting.
