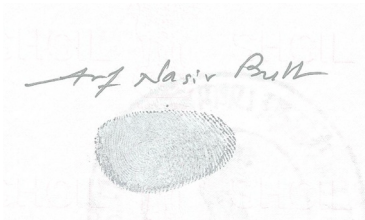

This Deed of public charitable trust is executed on this **23rd day of August, 2024** by **Mr. ARIF NASIR BUTT**, aged 40 years about, Son of Mr. Khawaja Nasiruddin, R/o Flat No. 2A, Krishna Tower, Gari Khana, Near Ram Mandir, Ranchi, Jharkhand-834001 (Aadhar No. 3187 5571 0112 & Pan Card No. ALZPB7941D) here in after called the "Settler" (which expression shall, unless excluded by or repugnant to the context, be deemed to include his executors, administrators and representative of the one part).

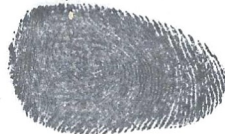

And whereas it is necessary to declare the aims and objects of the public charitable trust, being constituted under these presents

NOW THIS INDENTURE WITNESSES AS FOLLOWS:

- That, in order to effectuate his aforesaid desire, the Settler has set apart and handed over to the trustees, a sum of **Rs. 10,000/- (Rupees Ten Thousand only)** (hereinafter called the "Trust Fund" which expression shall include cash and any other property of investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.

4. THAT THE OBJECTS FOR WHICH THIS TRUST IS ESTABLISHED ARE:

The Purposes of the INTERNATIONAL HUMAN RIGHTS COMMISSION are:

1. To maintain international peace and security, and to that end: to take effective collective measures for the prevention and removal of threats to the peace, and for the suppression of acts of aggression or other breaches of the peace, and to bring about by peaceful means, and in conformity with the principles of justice and international law, adjustment or settlement of international disputes or situations which might lead to a breach of the peace;
2. To develop friendly relations among nations based on respect for the principle of equal rights and self-determination of peoples, and to take other appropriate measures to strengthen universal peace;
3. To achieve international co-operation in solving international problems of an economic, social, cultural, or humanitarian character, and in promoting and encouraging respect for human rights and for fundamental freedoms for all without distinction as to race, sex, language, or religion; and

4. To be a center for harmonizing the actions of nations in the attainment of these common ends.
5. The General Assembly shall initiate studies and make recommendations for the purpose of:
 - A. promoting international co-operation in the political field and encouraging the progressive development of international law and its codification;
 - B. Promoting international co-operation in the economic, social, cultural, educational, and health fields, and assisting in the realization of human rights and fundamental freedoms for all without distinction as to race, sex, language, or religion.

The Transnational Intergovernmental Organization „International Human Rights Commission“ (IHRC) is a dynamic force in the arena of global security, economy, and diplomacy, guided by the Vienna Conventions of 1961, 1975, and 1986, and confirming international governmental agreements. Our organization is registered in the states of New Mexico and New York as Interpol Center UN USA , enabling us to protect human rights and collaborate with law enforcement agencies to address various global issues, such as locating missing children, protecting women, combating child abuse, corruption, and human trafficking.

IHRC members, serving as ambassadors and chaplains, operate under the UN laws of chaplain protection, the Geneva Conventions of 1864, 1906, 1929, and August 12, 1949, as well as the Vienna Conventions of 1961, 1963, and 1986, and the United Nations

Laws Bulletin of 1999 to ensure the protection of chaplains under all circumstances. The IHRC leadership holds the rank of Ambassador at Large, and all members serve as chaplains. The organization has the authority to confer other degrees, ranks, and titles.

As the only organization without the participation of any government, we have gained recognition from numerous governments, government agencies, and supranational organizations as a Transnational Intergovernmental Organization.

Being the only entity not structurally or financially dependent on any political party or interest group, we can effectively implement programs and projects, relying on a neutral and efficient platform capable of operating outside official protocols.

Our organization enables the efficient and reliable connection of states, interest groups, agencies, and organizations in joint activities. The mutual cooperation of these entities, if possible at all, would require a significant amount of effort, resources, and time, with the main task being constant attempts to maintain it.

Operating a volunteer program called the Special Monitoring Mission (SMM IHRC), the IHRC groups over 12 500 active volunteers in 118 countries across six continents. Each team is ready, in addition to current charitable and humanitarian activities on behalf of IHRC, to work on projects assigned to them. The IHRC structure ensures professionalism, reliability, quality, and effectiveness in implementing undertaken tasks.

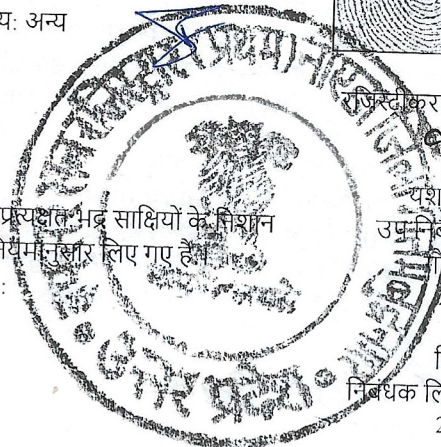

IHRC's diplomatic activities focus on achieving goals efficiently, without seeking popularity, applause, or self-advertisement. IHRC operates discreetly, remaining in the shadow and leaving honors to official institutions.

Below, we present selected programs, projects, and platforms implemented by IHRC:

1. FUTURE – AFRICA Program:

Rational stopping of illegal labor migration from African and Asian countries to Europe by redirecting them to development areas in Africa itself. By relieving European migration services, it additionally relieves these countries financially. Interested European countries and structures will be obliged to allocate part of the costs incurred so far to finance the program.

2. Economic Zones:

Economic, financial, and training elements of the FUTURE – AFRICA program. Zones made available by countries for the introduction of new techniques, technologies, and knowledge achievements to stimulate and intensify their economy. These zones will also be designated as areas of IHRC Diplomatic Missions, benefiting from full jurisdictional immunity granted by diplomatic agreements. They may refer to organizations cooperating in their areas and for their purposes, as well as to the people representing them.

3. United Organizations:

The IHRC platform, existing since 2021, groups entities interested in joint action and development with IHRC. This list includes organizations, enterprises, government ministries and agencies, local and trade union governments, churches, religious orders, and the media.

4. Free Ukraine – Free Europe:

As part of the multi-directional implementation of this program, the first economic zone will be created in southern Ukraine under the management of IHRC. It will be intended for the economic intensification of the region and will be a focal point for implementing the program of post-war comprehensive reconstruction of Ukraine.

5. Trans-African Railway Line:

In cooperation with IHRC and the governments of Somalia, Kenya, Uganda, and DRC, a project is being developed to build a transcontinental railway line, connecting the Arabian Sea with the Gulf of Guinea. The railway route will run between economic zones managed by IHRC, created in these countries as part of the FUTURE – AFRICA project. The advantages and benefits of the project are best demonstrated by the social and economic effects of the construction and opening of the Transcontinental Railroad in the USA in the 19th century.

The Transnational Intergovernmental Organization International Human Rights Commission, in accordance with the provisions of its statute, issues diplomatic Laissez-Passer cards, diplomatic Travel Order cards, and authorizations to mark vehicles with the CD symbol for persons participating in IHRC Diplomatic Missions. Currently, efforts are underway to obtain the ICAO code from IHRC and issue Laissez-Passer passports based on it.

a) Social:

- a. Whereas recognition of the inherent dignity and of the equal and inalienable rights of all members of the human family is the foundation of freedom, justice and peace in the world.
- b. To Promote UN universal declaration of human rights all 30 Articles some are given below
 1. All human beings are born free and equal in dignity and rights.
 2. Everyone is entitled to all the rights and freedoms set forth in this declaration, without any kind, such as race, color, sex, language, religion, political or other opinion, national or social origin, property, birth or other status.
 3. Everyone has the right to life, liberty and security of person.
 4. No one shall be held in slavery or servitude.
 5. No one shall be subjected to torture or cruel in human or degrading treatment or punishment. Everyone has right freely to participate in cultural life of the community, to enjoy the arts and to share in scientific advancement and its benefits. Everyone has the right to education. Everyone has the right to freedom of peaceful assembly and association. Everyone has right to seek and to enjoy in other countries asylum from persecution.
- c. To prevent corruption through research, advocacy, lobbying and awareness campaigns.
- d. To stimulate public awareness about corruption, corruption trends, corruption impact and to enable the civil society to raise their voice against corruption.
- e. To work for the betterment of women, children, senior citizens, and disabled and to fight against social wrongs like discrimination and harassment based on gender etc. with a vision of social justice.
- f. To help the poor in their social affairs vise arranging group marriages and inter caste marriages.
- g. To promote the cause of sanitation and construct toilets for Poor free of cost.
- h. To promote water conservation, educate about recycling of water, spread awareness for ponds and other water reservoirs.
- i. To eliminate child labor, child trafficking, and child abuse and focus on the education and resettlement of these deprived children.
- j. To fight against corruption and make people aware about their legal and consumer rights.
- k. To undertake and Re-construct Road, to plants, Shelters for shelter less, Pure & Safe Drinking Water Facilities, Rural Sanitation, Rural Development and other developmental works.
- l. Microfinance and SHG Group and RMK any other Micro Finance Objective.
- m. To establish and run various welfare Centre to promote de-Addiction, Welfare of senior citizens, physically and mentally handicapped person and overall human development.

b) Education, Research and Training:

- a. To promote, establish, run, develop and manage schools, colleges, Technical Institutions, library, coaching centers etc.
- b. To render, advice, give consultation, promote utilization of research and enhance, develop, exchange research programs and establish co-operation between institutions engaged in research in various fields of modern education.
- c. To promote education, especially girl and S.C, S.T, OBC Student education.
- d. To conduct educational, environmental and sociological studies.
- e. To promote use of Information & Communication Technology (ICT) for socio-economic development of the community.
- f. To push for legal and judicial reforms, civil service reform, and effective public administration.
- g. To improve accountability and transparency in political, administrative and social areas.
- h. To advocate a more efficient public financial management and public service delivery.
- i. To promote 17 global goals (officially known as Sustainable Development Goals or SDGs). These goals have the power to create a better world by 2030, by ending poverty, fighting inequality and addressing the urgency of climate change.
- j. To organize training and refresher programmers for the volunteers and officials of different Non-Government Organizations to strengthen the development skills of trainees through IEC (information, education and communication) which they can use in the development sector.
- k. To disseminate information and knowledge, to edit, publish, and print literature and documents and to organize seminars/ conference/ meetings etc.
- l. To manage skill development programs and promotes participation of youth (unemployed as well as students) in income generation activities.
- m. To organize lectures, seminars and workshops to help or strengthen the character building process.
- n. To remove illiteracy and to spread Adult Education for the age group: 15-35 years.

c) Women Empowerment:

- a. To fight against all types of violence being committed against girl, child and women and to make aware society against such evils like dowry, molestations and the like.
- b. To train women for self-employment through vocational courses to be conducted free of cost to attach and Gate or made on self-help group upgrade them about loaded for them by NABARD and other such organization.
- c. Empowering women through marketing linkages of their produces/ products for ensuring food and livelihood security and self-sustained economy.
- d. To educate women about family planning and benefits thereof.
- e. To work for uplifting the status of women in the society and to work against female circumcision and fight against the victimization of girl/ women by anybody in the society on female circumcision on any other related issues.

d) Health:

- a. To promote establish, run, develop and manage hospitals, medical colleges, research institutions, counseling centers, dispensaries etc.
- b. To educate people against taking drugs and alcohol.

- c. To provide help under health and nutrition services for women and children.
- d. To organize blood donation camps, immunization and encourage organ donation.
- e. To provide free medicine in deprived residing in rural areas by arranging medical fair mobile dispensaries giving free medicine.
- f. To create awareness as to fight disease like leprosy, tuberculosis, malaria, jaundice, Cancer, HIV/ AIDS etc.

e) Environment:

- a. To work for environmental awareness, sustainable development and participative management of local natural resources for village level development.
- b. To ensure environmental sustainability, ecological balance, production of flora and fauna, Agro forestry, conservation of natural resources.
- c. Plantation and Forestation.
- d. To create awareness about disaster management and to help the victims of natural disasters like floods, earthquake, Tsunami, fire, wind storm, cyclone etc.

f) Agriculture, Horticulture:

Encouraging sustainable agriculture development, Horticulture and Land Development.

- a. To promote organic production and their marketing in the area of agriculture.

g) Animal Welfare:

- a. To work for animal husbandry, animal medical care, animal right and to implement project on Development on fisheries.
- b. To help the victims of natural disasters be it animals.

h) Sports :

- a. To organize Sports events and talent search events for the youth.
- b. To promote and provide training for rural sports, National recognized sports and Paralympics sports and Olympic Sports.
- c. Career games as to the development of an education courses.

i) Other :

- a. To public newspaper, magazine, general and reproduce of arts, literature, science, craft and other allied works/ collections of works of arts for instruction and imparting useful knowledge.
- b. To eliminate Poverty, unemployment and starvation such as rural industries, home industries, small industry, small scale industries and efforts to ensure proper market conditions.

6. PATRONS:

The governing body may according to such terms and condition as it shall decide from time to time admit as patrons those persons who are likely to help in furthering the objective and causes of the trust either through their professional knowledge and experience and /or through financial assistance.

7. TRUSTEES:

All persons who have attained 18 years of age and have subscribed to the aims and objects of the Trust subject to the approval of the Governing Body will be entitled to be its Trustees. The Decision of the Governing body in this regard shall be final and binding.

The Trustees will not be entitled to receive any profit, but the Trustees may receive honorarium and reimburse all expenses actually incurred by them in connection with their duties relating to Trust.

The Trustees shall be accountable only for such moneys, and funds, which will actually come into their hands.

8. TERMINATION OF MEMBERSHIP OF TRUSTEE:

On death

On written resignation

On unsound mind

If found to be involved in any anti-social activities

If found guilty by means of anti-propaganda of the Aims and Objects of the Trust

If has not attended three consecutive meeting of the Governing Body without information

If he is requested to resign by 2/3rd or as near thereto possible of the remaining Trustees

9. Governing Body of the Trust

The following persons shall form the Governing Body of the Trust.

Mr. ARIF NASIR BUTT : **President/ Founder**

MRS. SHEFA PARVEEN : **Secretary**

MR. IMRAN KHAN : **Treasurer**

10. MANAGING TRUSTEE

Mr. ARIF NASIR BUTT is designated as the **MANAGING TRUSTEE (Founder/ President)** of the trust. He will be at liberty for the time being to appoint additional trustee within the number mentioned above for such period or on such terms as to retirement and re-appointment as the trustees for the time being consider proper.

11. MEETINGS

The governing body will be held, at least, once in four months, notice of such meeting being given, at least, 15 days in advance. Decision will be taken as far as possible by consensus and in the event of any difference by majority where the votes are equal; the Chairman will have the casting vote.

The meeting of the Governing body shall be held at such time and place as the Chairman may decide from time to time and all the meeting of the Governing Body shall be presided over by the Chairman and in his absence by any one of the trustees. The annual general meeting shall be held not later than six months after the closing of the financial year.

12. ACCOUNTS

Audit of Accounts:

A Chartered Accountant shall audit the accounts of the trust/society every year.

OPERATION OF BANK ACCOUNT:

The governing Body have power to open account in the name of the Trust, with a Bank or Banks, to operate any government or private bank such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.

SETTLEMENT OF ACCOUNT:

The Governing Body will settle all accounts and to compromise, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.

13. BRANCH OPEARATION:

Branch can be open in any state of India; no new registration would be required for state branch office.

14. POWERS AND FUNCTION OF OFFICE BEARER:

PRESIDENT:

- I. President shall preside over all the meeting of the trust and have the power to allow inclusion of any subject/matter in agenda for the discussion in the course of proceeding/meeting.
- II. President shall make disbursement in accordance with the direction of Governing Body and shall maintain accounts books minute register and manage daily routine correspondence.
- III. At the time of voting on any matter/subject if the total votes of the group of members happen to be equal in number; the President will have casting vote to decide the matter/subject.
- IV. President shall preside over all the meeting of the society.
- V. At the time of voting on any matter/subject (except election) if the total votes of the group of members happen to be equal in number; the Chairman has the power to cast an extra vote to decide the matter/subject.
- VI. President shall have the power to allow inclusion of any subject/matter in agenda for the discussion in the course of proceeding/meeting.

- VII. President shall be convener of all the meetings and without his/her signature on the notice of meetings no meeting will be valid. It shall be his/her duty to see that the resolution at the respective meeting is implemented and given effect timely.
- VIII. President shall be at liberty to spend for the purpose of the Society without sanction of the Managing Committee and to do all such other lawful things as incidental or conducive and expedient to the Society.
- IX. While purchasing or acquiring any movable or immovable property on behalf of the President will sign along with secretary.
- X. In case of resignation of the President it will be addressed to Secretary

SECRETARY:

The Secretary shall enjoy all the powers of President in his/her Absence.

- I. Secretary will prepare the Membership Register as well as the Proceeding Register to record the minutes of the proceedings of the Governing Body Meetings and have them duly signed by the members who attend the meetings.
- II. Secretary shall maintain the accounts of all money, which is received and/or paid by him/her on behalf of the trust.
- III. Secretary shall make disbursement in accordance with the direction of Governing Body.

FINANCE EXECUTIVE (Treasurer):

- I. Treasurer shall maintain the accounts books and all money, which is received and/or paid by him/her on behalf of the trust.
- II. Treasurer shall make disbursement in accordance with the direction of Governing Body.

15. FINANCIAL YEAR:

The financial year of the trust shall be from 1st April to 31st March of every year.

16. POWER TO SUE:

The trust may sue or be sued in the name of the **Managing Trustee**

17. RECORD

The Governing Body will maintain a record of investments and disbursements besides a Minutes Book recording all resolutions and proceedings for every meeting duly confirmed at next meeting and attested by the Chairman of the next meeting.

18. COMMITTEES:

Trust can permit its beneficiaries to elect committee or committees from among themselves for the smooth and efficient running of any particular branch of its activities. They can form rules and regulations for that particular branch under the given condition.

19. TRUST FUND:

That the trust fund may be augmented by the income from the fund and also by donations and other contribution from time to time.

That the trust fund shall not be applied for any purpose other than those specified in Para 5 herein above unless the other objects added to the trust objectives.

That the Trustees shall always maintain proper books of accounts which shall be kept at the office of the trust.

In the matter of investment of Trust funds, the provision of section 20 of the Indian Trust Act 1882 shall apply.

20. POWER AND FUNCTION OF THE GOVERNING BODY:

To fill the vacancy created by death or otherwise within three month of the occurrence of such vacancies by appointing any person as trustee.

The Governing Body of the trust will be empowered to open administrative office, Regional office, branch offices and central office of the trust in different states of India.

To administer and control the affairs and funds of the Trust and exercise all power of the Trust in order to carry out the aims and objects of the Trust and manage all the institutions established by the Trust.

To purchase take on lease or in exchange or hire or otherwise acquire any movable or immovable property for the purpose of the Trust and to carry out agreement, loan, grants and other assistance in suitable terms.

To provide grant in-aid and other financial assistance to voluntary organization and work as link between working in different parts of India and donor agencies and individual donors.

To accept any donation, contribution, grant-in-aid, subscription in cash or in kind from any person, body of persons, trust, foundations, Govt. Departments or Funding agencies with or without conditions.

To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto to, any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.

To start, abolish, discontinue and restart any charity of charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.

To take over, acquire, manage, control or amalgamate with any Institution having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.

To join, co-operate or amalgamate this trust with other or others having allied objects upon such terms and conditions as the trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.

To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and /or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.

To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise to different charitable institutions, societies organizations or Trusts in India which may have been established or which may hereinafter be established for the like charitable purposes

To grant loan to institutions or persons either on interest or without interest on such terms and conditions as trustees may in their absolute discretion think fit and set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund.

To apply for grant-in-aid or donation to the Government Departments and Funding Agencies and to accept grants, donations, gifts, subscriptions, affiliation and other assistance with a view to promote the objects of the Trust and to put to any proper condition upon which such grants and other payments may be made.

The Governing body shall meet as often as necessary but at least once in every calendar quarter at such place and time as the Managing Trustee may decide. He will send the notice and agenda of these meetings to all members of the Governing Body at least fifteen days before the date fixed for the meeting. The quorum for the meeting shall be one third subject to minimum two trustees.

Whenever the Managing Trustee is of the opinion that a special meeting of the Governing Body is to be called to discuss and decide an urgent matter of shorter duration the Managing Trustee and any one of the trustees will form sufficient quorum and they may take necessary decisions on behalf of the governing Body in such emergency meeting.

The Governing Body shall have the power to determine in case of doubt whether any money or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses to be paid provided that nothing contained shall be deemed to Trustees to spend the income or corpus of the trust for any purpose not authorized by these presents.

To engage or make provision for the engagement of any person (including all or any of the Trustees and committees or administrator or Managing Trustees or otherwise) for the purpose of the administration of the Trust in such rules and regulation as the Trustees may prescribe and also to engage or provide for the engagement.

To borrow moneys either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purpose of these presents, and it shall be lawful for the trustee to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.

21. INVESTMENT:

We undertake that the society/trust/company would only invest its money in the forms or modes specified in section 11(5) of I.T. Act. We further undertake that the company/society/trust/ will insert relevant clause in desired format in MOA/ Trust Deed, if required.

22. AMENDMENT:

We undertake that the company/society/trust will not make any amendment in the object clause without the consent of concerned authority .We further undertake that the company/trust/society will insert the relevant clause in MOA/Trust Deed, if required.

23. BENEFICIARY:

We further undertake that the trustees or their relatives would not be beneficiary of the trust. The beneficiaries of the trust would be weaker section of the society/trust/company and the people generally required help and assistance in different facets of their lives.

24. SEAL OF THE TRUST

Whenever the seal of the Trust is to be affixed to any writing deed or document executed by the Trust the same shall be affixed in the presence of persons executing the document. The seal of the Trust shall not be affixed except under the authority of a resolution of the Governing Body.

25. DISSOLUTION:

In the event of dissolution of the trust the funds / assets will be transferred only to some other trust/ society having similar objectives after adjustment of liabilities.

In the Event of Dissolution of the Trust, the entire Society funds shall be realized and first be used for payment of liabilities of the trust. The assets left if any, shall be disbursed, after obtaining prior approval of the commissioner of Income-tax (Exemption) New Delhi, to other Trust having similar objectives and who have been granted registration u/s 12AA of the Income Tax Act, 1961. In no circumstances it shall be distributed in any manner, to any member of the Trust or their relatives or related concerns.

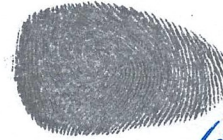

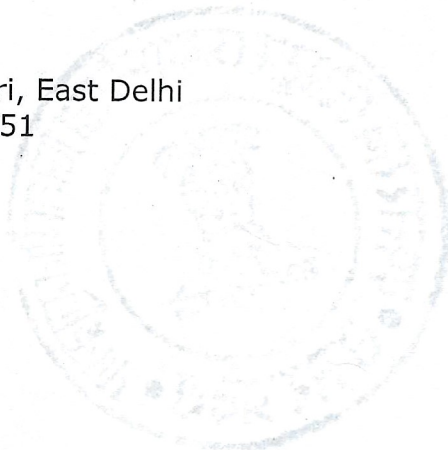
